Application Deadline - Friday, September 17th, 2022

A Late Fee of \$10 will be added to application fees received after this date.

To reserve a spot at the Olive Festival the following must be returned by October 1, 2022: a signed and completed application/vendor agreement, any required documentation for your business and payment. If you fail to submit the required paperwork and/or payment by this date you will not have a space at the festival.

### PAPERWORK AND PAYMENTS WILL NOT BE ACCEPTED THE DAY OF THE EVENT

Booth locations will be assigned by the committee and a confirmation letter with an event map will be sent out the week leading up to the festival.

All vendors are required to provide their own tables and chairs. A canopy is strongly suggested as shade is limited at the park, also bring weight in case of wind. There is no electricity or water available at the booth sites.

### Vendor Agreement

- Vendor agrees to comply with all laws and regulations which apply to the operation of their particular concession, including any Health Department Regulations concerning food as well as any other public entities which govern the activities of the concession being operated.
- The Vendor agrees to protect, defend, and hold the City of Corning, the Corning Chamber of Commerce, and the Event Committee harmless from and against any liability of any kind arising out of the Vendor's operations of a concession at the event. This agreement extends to all injuries and damages to persons and/or property except that caused exclusively by the Committee, their officers, agents, employees, or volunteers. This agreement extends to the agents and employees of the City and to its officers and officials.
- The Vendor acknowledges that the operation of any activity at this event involves a certain amount of risk from accidents which could occur. Nevertheless, Vendor agrees to risk any such accidents or injuries on its own behalf of officers, agents, and or employees and agrees to hold the City of Corning, the Corning Chamber of Commerce and the Event Committee, their officers, agents and /or employees or volunteers harmless.
- The Corning Chamber of Commerce retains the right to terminate this agreement on one week's notice provided to the Vendor. This agreement may be terminated on even less notice if the 2022 event is canceled or the Vendor breaches any of the terms hereof. No liability shall result to the City of Corning, the Corning Chamber of Commerce, or the Event Committee as the result of any cancellation of the 2022 event or termination of this vendor agreement.

This signed agreement represents the entire agreement between the Vendor and the Corning Chamber of Commerce/Event Committee with respect to the operating of a concession. There are no oral promises or commitments to the terms of which are not included within the written terms hereof.
